### FACTS

#### WHAT DOES MACKAY SHIELDS LLC DO WITH YOUR PERSONAL INFORMATION?

#### Why?

The Privacy Notice is being provided by MacKay Shields LLC and the private funds for which it serves as investment adviser (collectively “we”, “us” or “our”). Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please note that this privacy notice applies only to individuals who receive or have received a financial product or service from us mainly for personal, family or household purposes. It does not apply to institutions. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Name, address, birth date, social security number, income and household information.
- Information about your account balances and financial transactions with us, such as types of products you purchased, account status, or trading history.
- Information gathered from our websites, such as through online forms, site visit data and information collection devices (“cookies”).
- Information from outside sources, such as public information.
- Information collected from consumer reporting agencies.

#### How?

All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons MacKay chooses to share; and whether you can limit this sharing.

Access to customer information is limited to people who need the information to perform their job responsibilities. We regularly update and improve our security standards, procedures, and technology to protect against unauthorized access to your information.</p>
<p><b>How does MacKay Shields LLC collect my personal information?</b></p>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>• Open an account, or invest or apply to invest in our private funds</li> <li>• Conduct transactions in your account, such as trades, deposits or withdrawals</li> <li>• Provide us your income information</li> <li>• Show us your government-issued ID for verification purposes</li> <li>• Provide account information</li> </ul>
<p><b>Why can't I limit all sharing?</b></p>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>• sharing for affiliates’ everyday business purposes—information about your creditworthiness</li> <li>• affiliates from using your information to market to you</li> <li>• sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>

## Definitions

<p><b>Affiliates</b></p>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• <i>Our affiliates include companies listed on the New York Life Family of Companies.*</i></li> </ul>
<p><b>Nonaffiliates</b></p>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• <i>New York Life Investment Management does not share with nonaffiliates for marketing purposes.</i></li> </ul>
<p><b>Joint marketing</b></p>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>• <i>New York Life Investment Management does not jointly market.</i></li> </ul>
